## NOTIFICATION

The Labour Department, vide its Order Labr/880/(LC-IR)/IR/3C-04/2015 dated 29<sup>th</sup> August, 2017 had introduced "COMPREHENSIVE INSPECTION POLICY – 2017" for carrying out inspections under all or any of the Laws mentioned therein.

In exercise of provisions under Clause VIII (i) of the policy, the Governor is pleased to insert a new clause in the above said policy at Section VIII (iii) with the following provisions:

- " [VIII (iii)] The owners of the establishments would be intimated about the dates of routine compliance inspections atleast 15 days in advance. The channel of communication of prior inspection notices would be all or any of the following:
- a. System generated real-time Electronic Alerts via SMS and / or via email(s) to the registered mobile number(s) and / or email address(es) of the respective owner(s). These alerts would be generated automatically while scheduling of inspections by the respective online Computerized Inspection Systems.
- b. The system generated inspection schedule(s) would be published atleast 15 days in advance, on the respective portals of the Directorates and/ or the portal of the Labour Department [wblabour.gov.in]"

The owners of the establishments registered under any of the Acts being administered by this Department are requested to update their contact details on the respective portal(s) at the earliest to avail this facility and also to visit the portal of the Labour Department and respective Directorates, at regular intervals.

This shall come into immediate effect. All concerned are hereby being informed accordingly.
