NOTIFICATION

The Labour Department, vide its Order Labr/880/(LC–IR)/IR/3C–04/2015 dated 29th August, 2017 had introduced "COMPREHENSIVE INSPECTION POLICY – 2017" for carrying out inspections under all or any of the Laws mentioned therein.

In exercise of provisions under Clause VIII(i) of the said Policy, the Governor is pleased to include, at serial (**xx**), the Indian Boilers Act, 1923 on to the list of applicable Acts mentioned under Clause IV of the said Policy. The provisions of the abovesaid Policy, read with this Department's notification: Labr/644/Dte(Boil) dated 30/11/2018, shall be applicable to the Indian Boilers Act with immediate effect, wherever deemed pertinent and appropriate as per existing rules.

The Governor is further pleased to add sub-Clause "(**A**)" in the said Policy under **Clause VII** titled "Common Inspection System"; that shall read as follows:

"... VII(A): All notes, reports and annexures of inspection, conducted under the Acts & Rules mentioned in this policy, should be submitted ONLINE within 48 hours after completion of the inspection. Real–Time submission of such notes, reports and annexures of inspection shall be priority of this Department, wherever plausible and feasible.

The concerned Directorates are hereby authorized to permit delayed online submission of such notes, reports and annexures of inspection on grounds such as natural calamity, unavailability of data network or any such reason that may be beyond the control of the concerned inspector/ officer. However, the delay in online submission must not exceed 48 hours after completion of the inspection.

Registered Establishments or Business Entities shall have access to view and download inspection reports, including those of past two years."

This order shall have immediate effect. This issues in supersession of the following previous orders issued in this regard: –

- (ii) 470-IR/3C-04/2015 dated 23rd May, 2016
- (iii) Labr/120/IT & EoDB dated 18th August 2017
