## NOTIFICATION

Whereas, the inspectors under different Directorates of the Labour Department cause inspection of factories, shops, establishments etc. being empowered under different Acts & Rules. But it is observed that the submission of the inspection report to the respective authority(s) is often delayed; and

Whereas, the Labour Department vide its Circular No: 221–IR/3C-04/2015(Pt) dated 03<sup>rd</sup> March, 2015 ordered that reports of inspections of establishments, factories, shops etc. under the different Acts & Rules being administered by the various Directorates under this Departments, are to be submitted to the respective authority(s) within Seventy Two (72) hours after the completion of the inspection; and

Whereas, the Department of Industrial Policy & Promotion, Ministry of Commerce & Industry, Government of India has recommended to the Government of West Bengal, in the "Business Reform Action Plan -2016" to mandate online submission of inspection report within Forty Eight (48) hours.

Hence, in pursuance of the recommendation made by the Department Of Industrial Policy & Promotion, Government of India and in partial modification of the abovesaid circular, it is hereby ordered that the reports of all inspections, which are carried out by the Inspectors working under various Directorates of this Department as per provisions of the aforesaid Acts & Rules are to be submitted to the respective authority(s) within Forty-Eight (48) hours after the completion of the inspections instead of Seventy Two (72) hours as ordered earlier.

This will come into effect on the date of issuance of this Notification.
